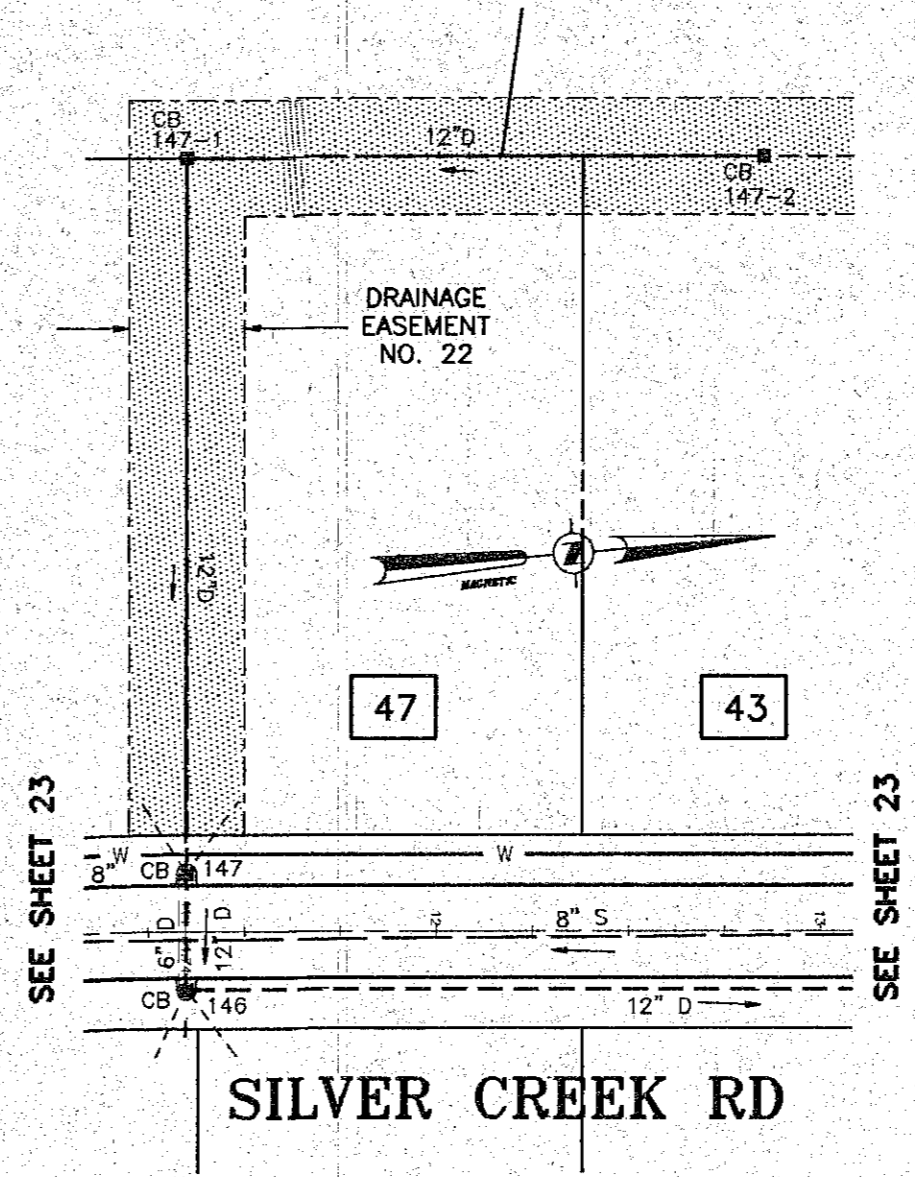


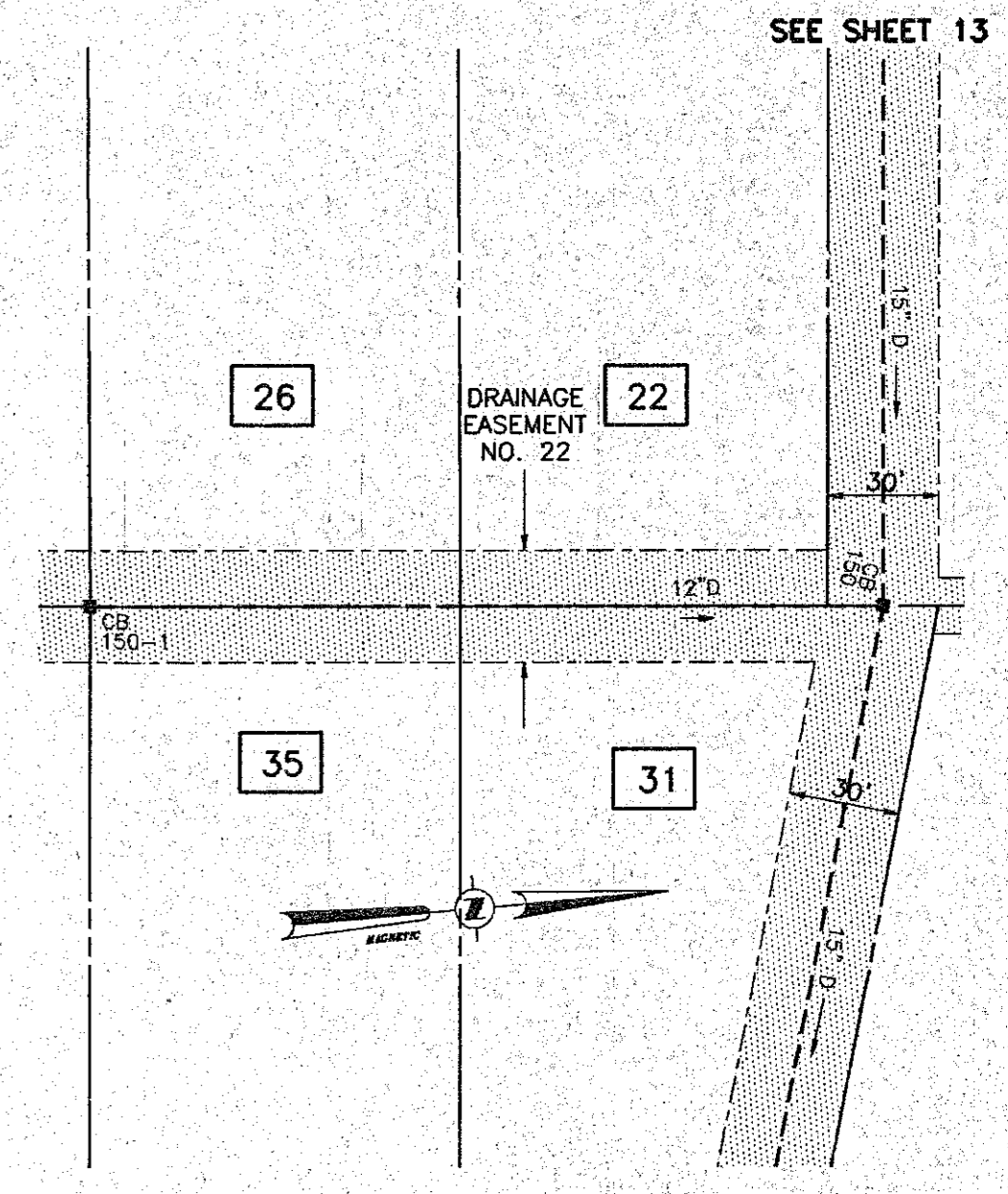

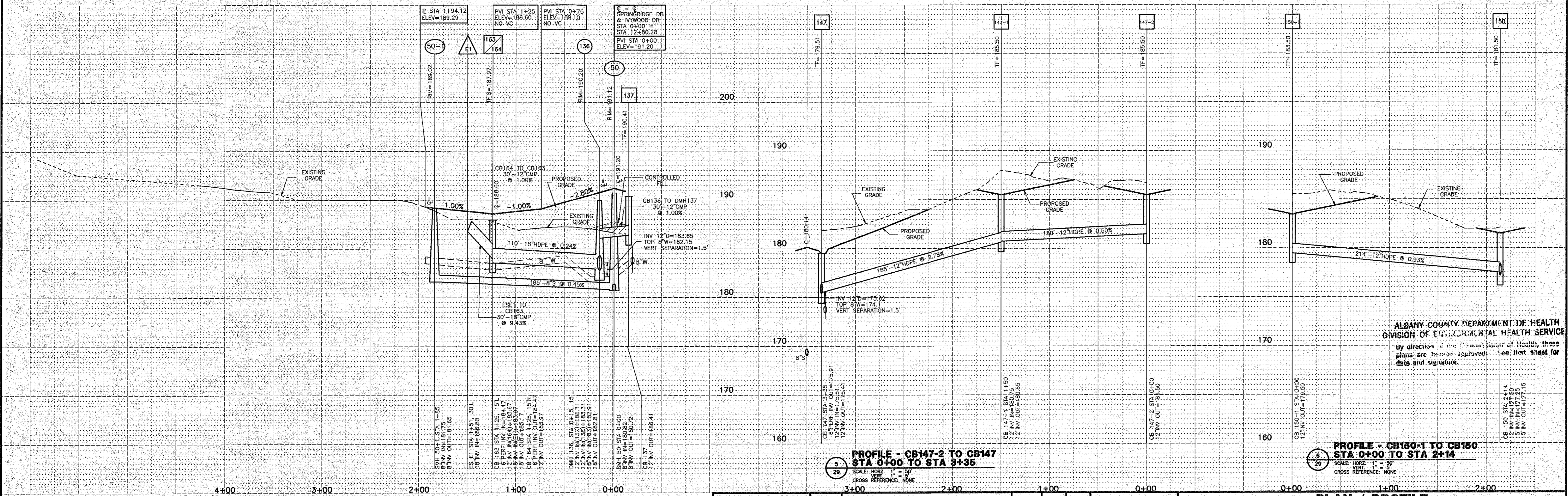
- ALL UNDERGROUND UTILITIES ARE SHOWN IN THEIR RELATIVE POSITION AND ARE FOR INFORMATION ONLY. THEIR EXACT LOCATION SHALL BE CHECKED AT THE SITE BEFORE CONSTRUCTION BEGINS.
- SEWER MAINS & LATERALS IN RELATION TO WATER MAINS & LATERALS, WHERE POSSIBLE, SEWER SHALL BE LAID AT LEAST 10 FEET HORIZONTALLY FROM ANY EXISTING OR PROPOSED WATER MAIN OR LATERAL. WHEN SEWER & WATER MUST CROSS, A VERTICAL SEPARATION SHALL BE MAINTAINED TO PROVIDE 18" BETWEEN TOP OF SEWER AND THE INVERT OF THE WATER AT CROSSING. CROSSING SHALL BE MADE WITH A FULL LENGTH OF SEWER PIPE CENTERED UNDER THE WATER BEING CROSSED.
- A 3 FEET SEPARATION WILL BE MAINTAINED BETWEEN CATCH BASINS AND WATER MAIN.

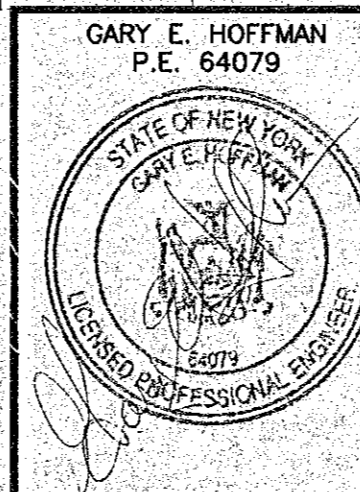
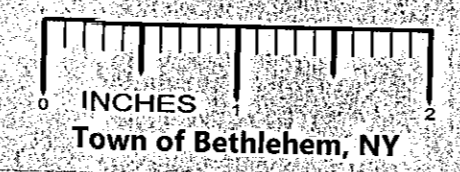
