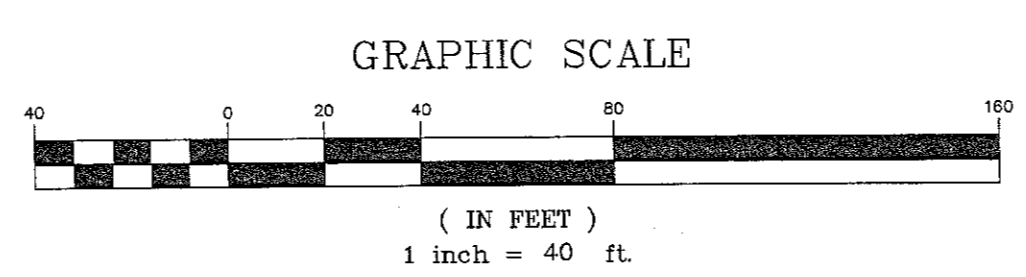
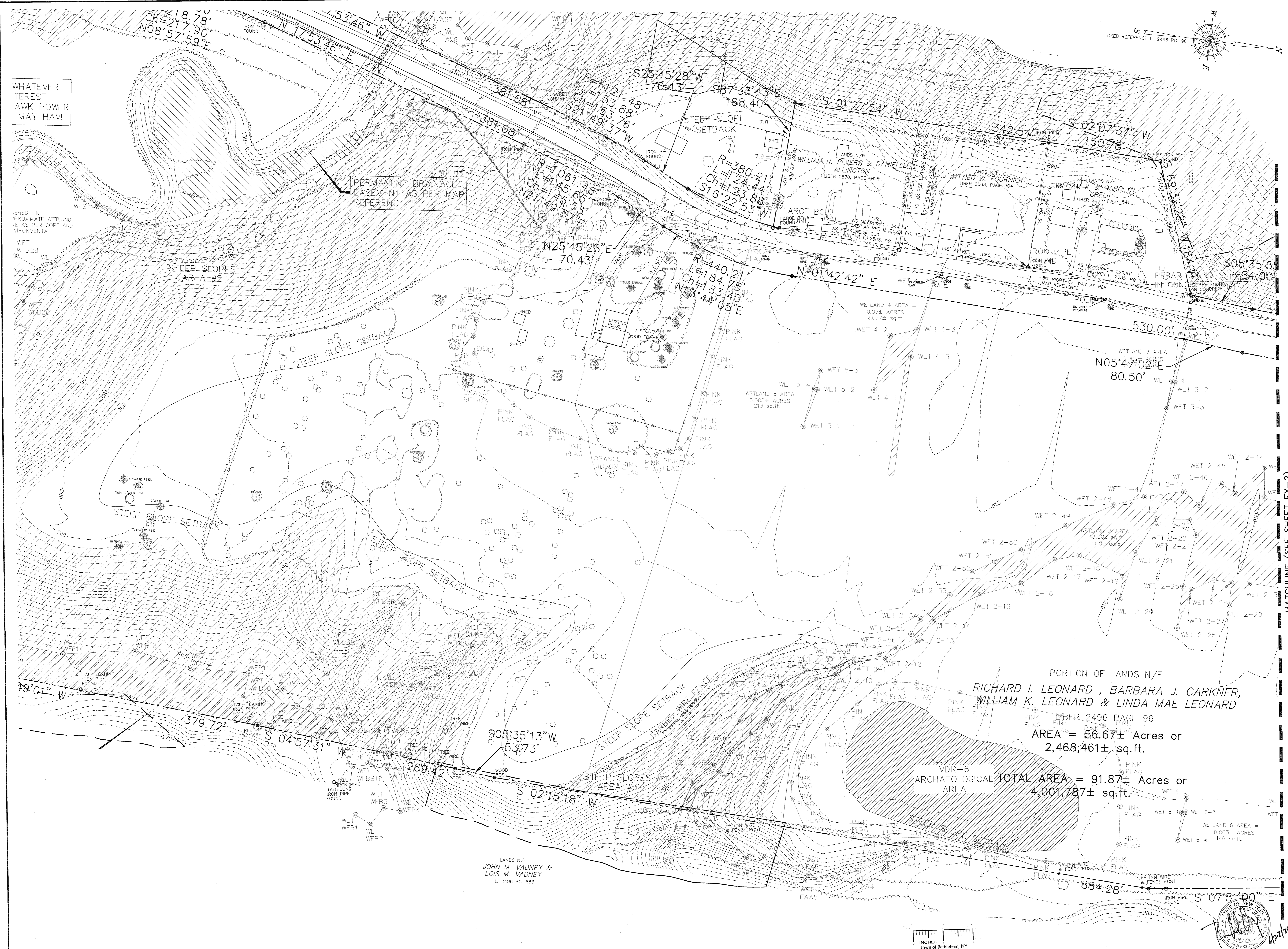
EXISTING CONDITIONS PLAN
