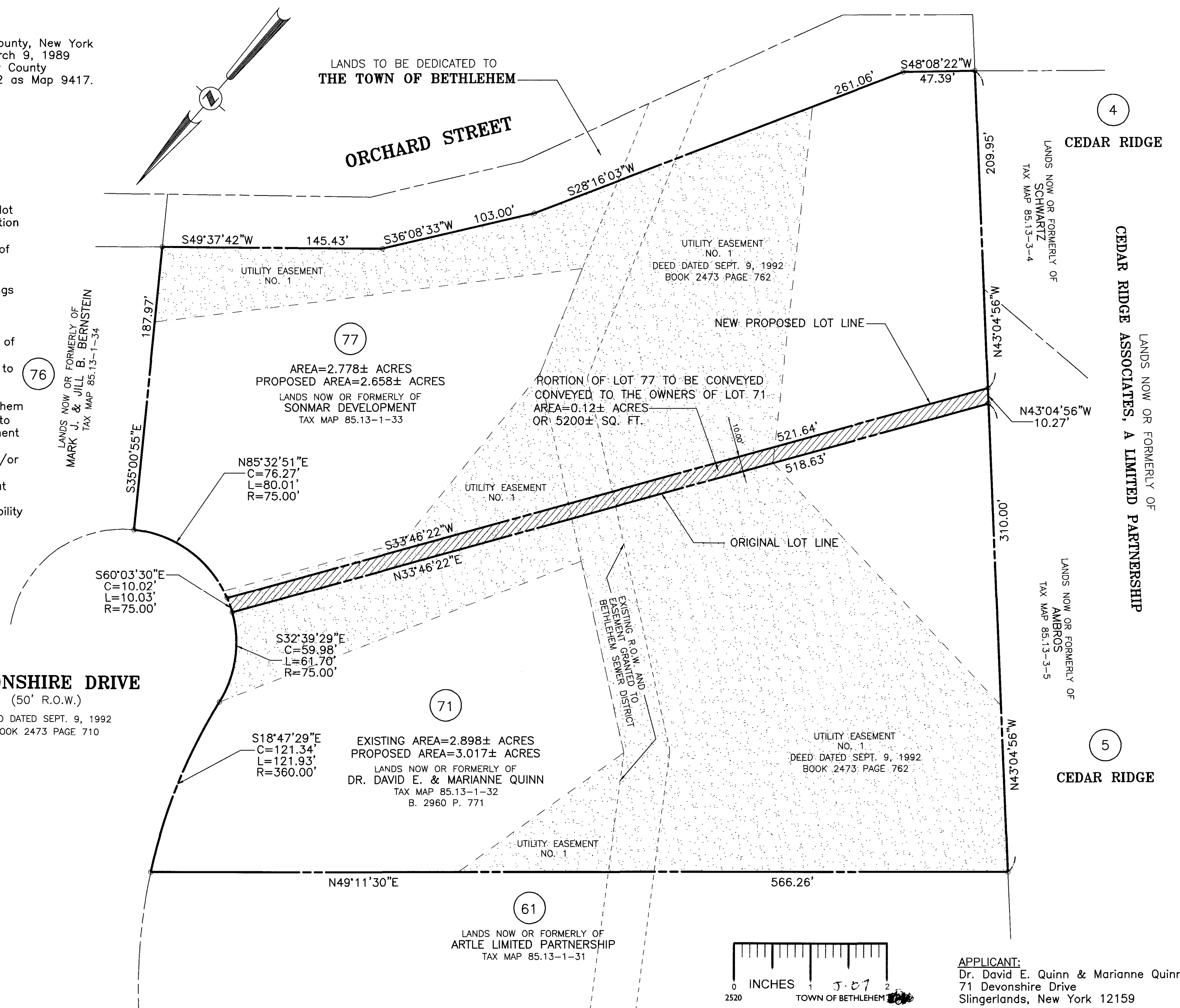


MAP REFERENCE:

NOTES:

- 1. No attempt was made to show any structures or improvements on the lots shown hereon.
- 2. This map is intended to convey information specifically related to the revision of the common lot line between Lots 71 and 77. For further information regarding these lots, see the Approved Final Plat drawings titled "Subdivision Devonshire Hills", Town of Bethlehem, Albany County, prepared by C.T. Male Associates, P.C. dated 3/9/89 and revised through 7/1/91, Sheet 1 of 11, and the associated drawings on file with the Town of Bethlehem.
- 3. Lot 71 contains certain structures and/or improvements that are located within the boundary of Utility Easement 1. Any private structures and/or improvements so located, including but not limited to retaining walls, fill volumes, irrigation systems, pavement and plantings, may be removed or demolished at the discretion of the Town of Bethlehem if said structures and/or improvements are found to impede access for maintenance, repair or replacement of municipal utilities located within the Easement. Costs and expenses associated with the repair and/or replacement of private structures and/or other improvements located within Utility Easement 1, that result from actions of the Town of Bethlehem in attending to its utilities, shall be the sole responsibility of, and borne by, the affected Lot Owner.

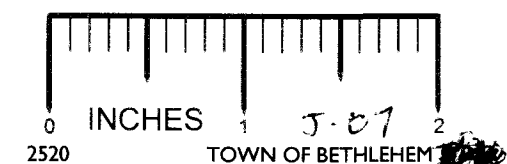
