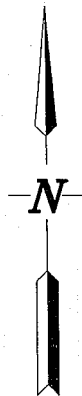
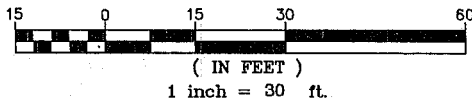
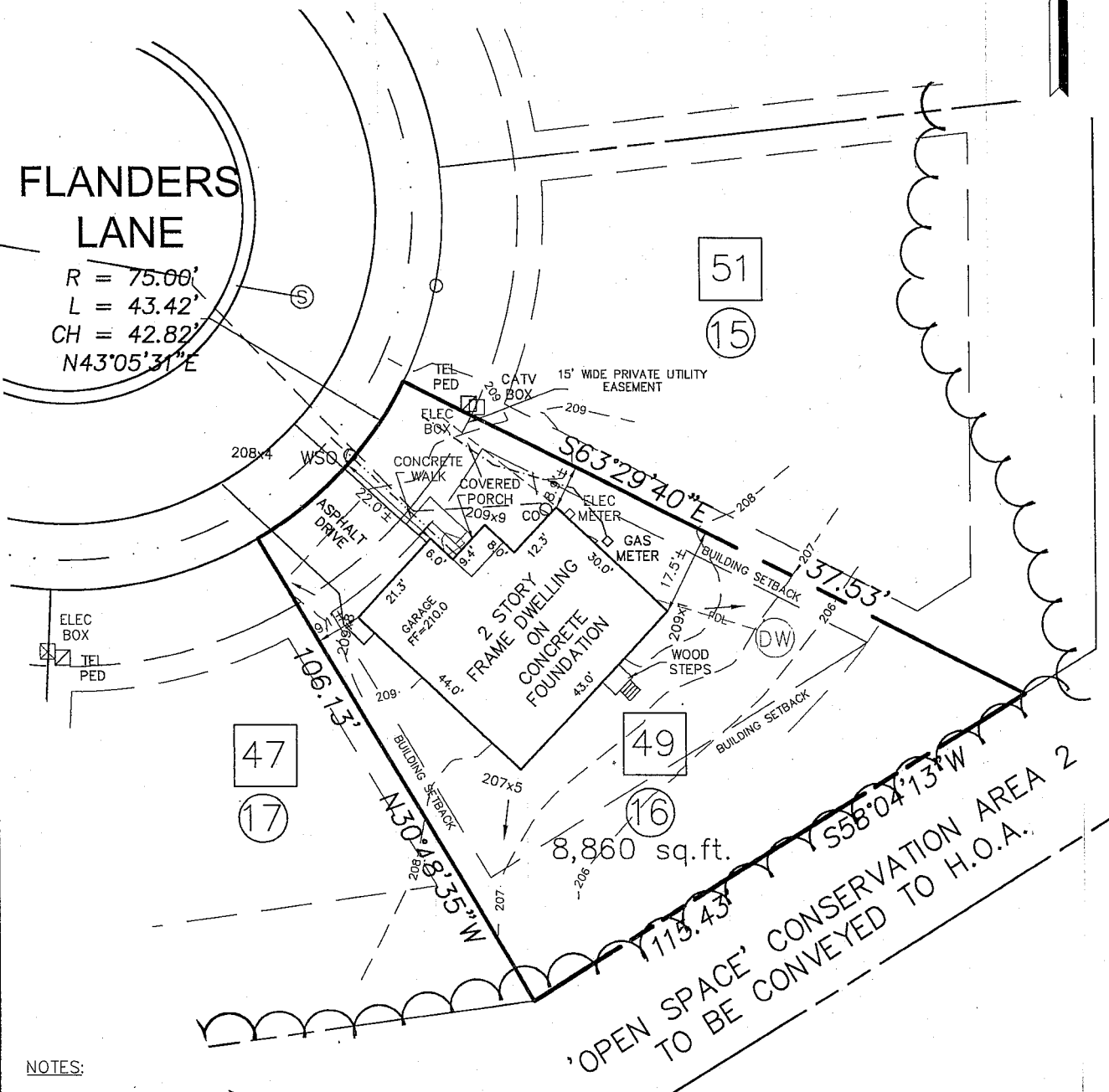


GRAPHIC SCALE

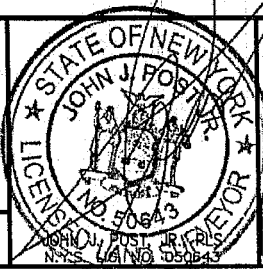
