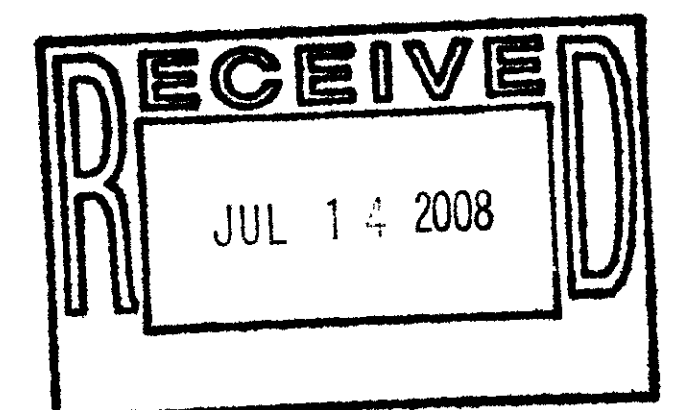
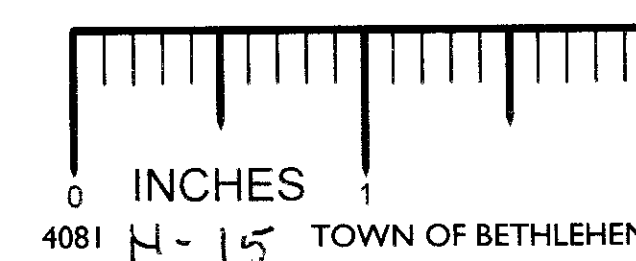

A field review of the surveyed premises shown hereon was made by a survey party from this office, which included Paul E. Hite. A number of minor changes have been made since the last update survey was made on March 03, 2005, such as the two wood rail fences at the northeast corner of the property are now a solid vinyl fence, the sidewalk and parking area on the west side of the property now has a six inch width by two inch height concrete block wall along same, a few bushes and trees have been removed, an attempt to repaint the parking stripes of the parking area located on the southerly side of Hudson Avenue to a different configuration but was not successful (no loss of spaces), a total of three (4" diameter) PVC pipe roof drains have been extended from both buildings to exit the property on the easterly side, no changes made to either structure.
