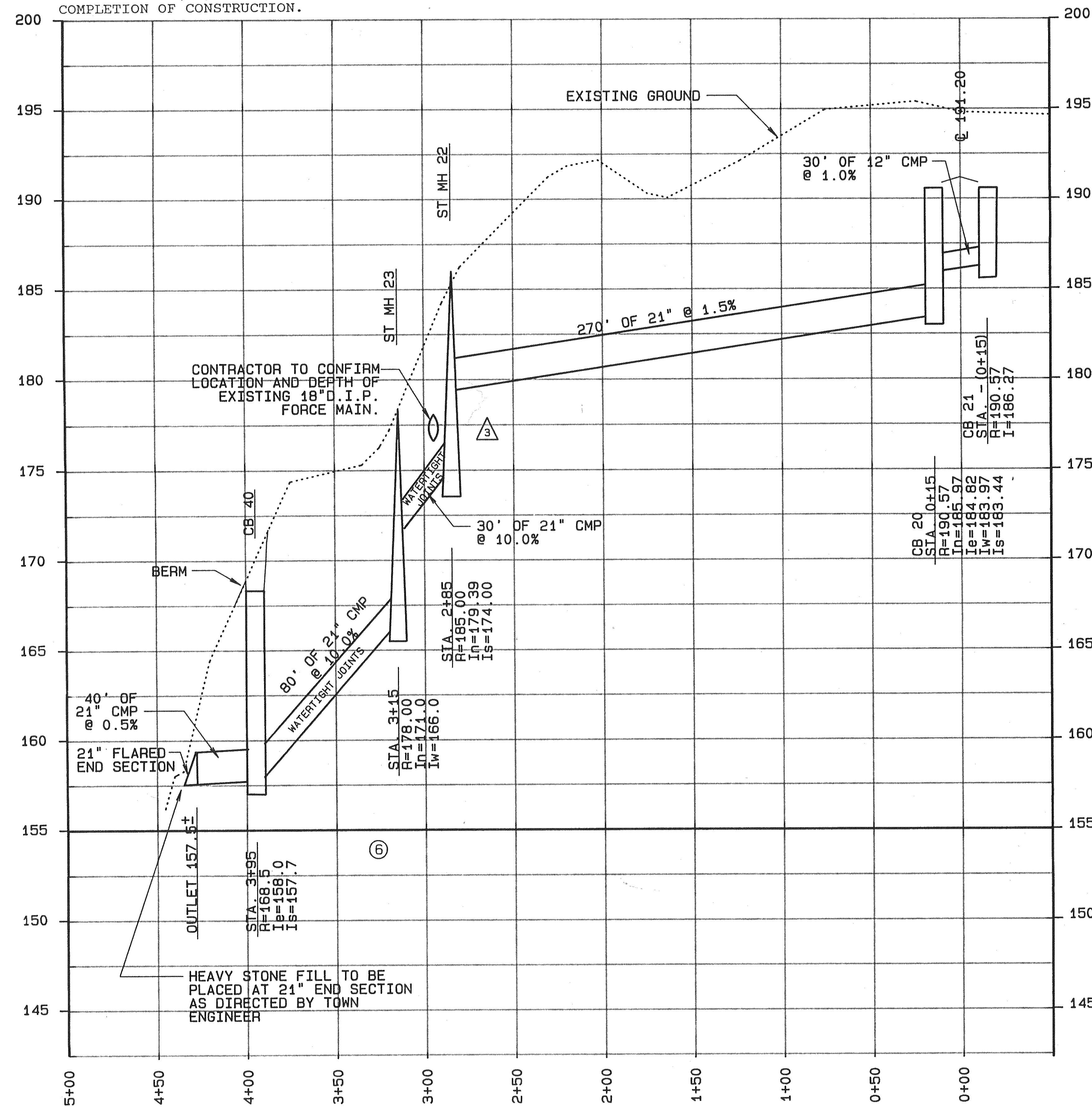
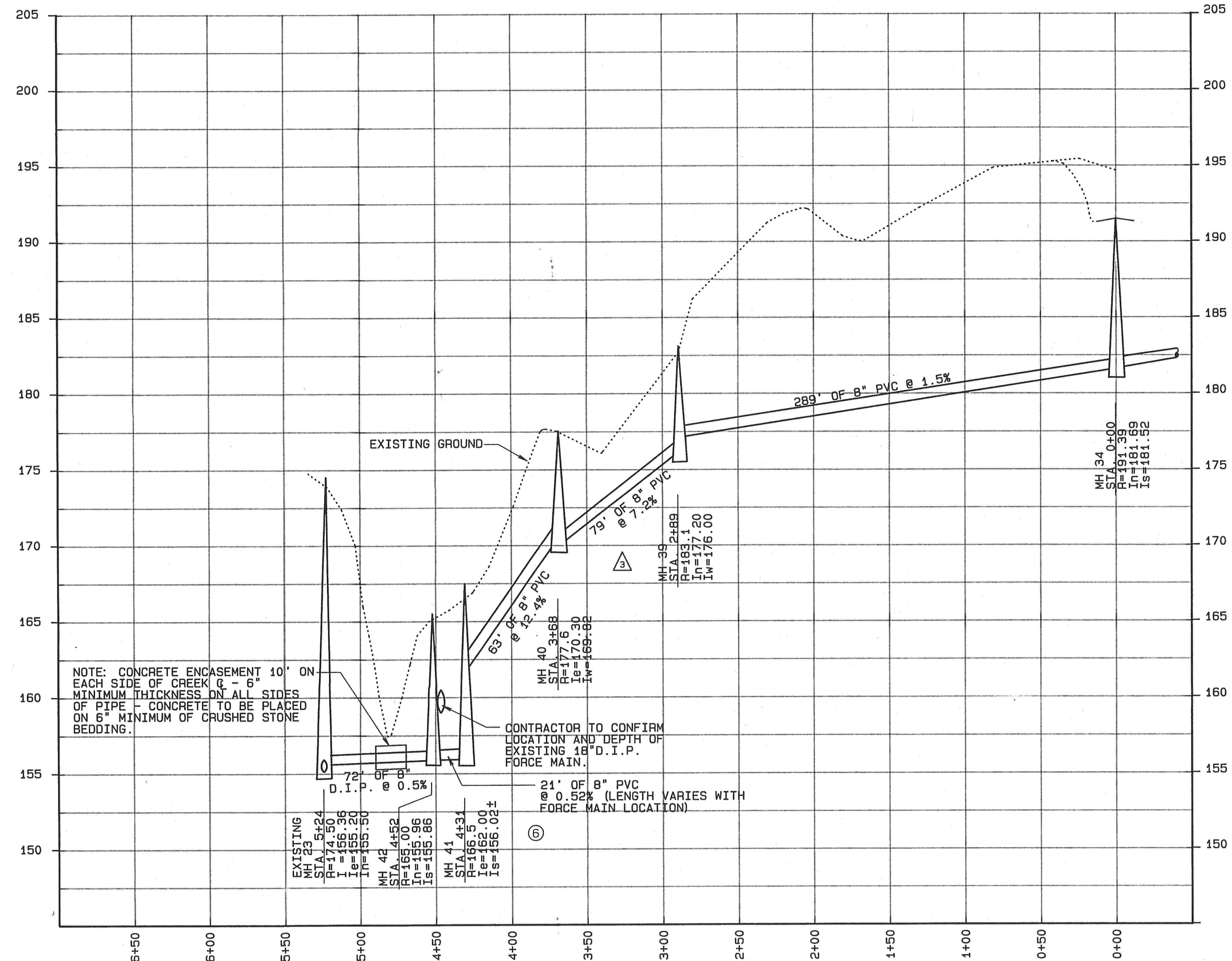


NOTE: SEWER LINES ARE TO BE INSTALLED UNDER THE SUPERVISION OF A NEW YORK STATE LICENSED PROFESSIONAL ENGINEER. ENGINEER SHALL SUBMIT A CERTIFICATE STATING THAT THE CONSTRUCTED FACILITIES HAVE BEEN CONSTRUCTED IN ACCORDANCE WITH THE APPROVED PLANS. CERTIFICATION MUST BE RECEIVED BY THE ALBANY COUNTY HEALTH DEPARTMENT WITHIN SIXTY (60) DAYS FROM THE COMPLETION OF CONSTRUCTION.



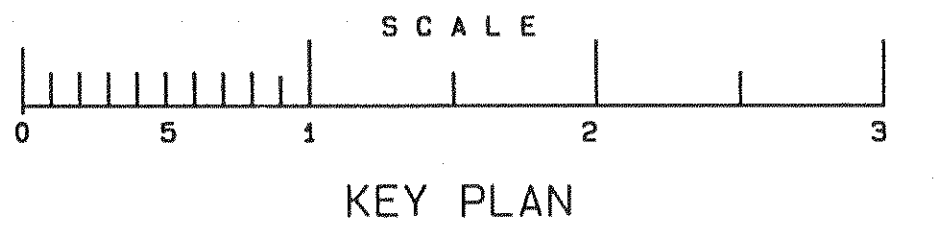
PROFILE - STORM SEWER OUTFALL

NOTES

GRADE OF GRAVITY SEWERS ARE CALCULATED BY THE FOLLOWING CRITERIA:

- 1.) LENGTH OF PIPE RUN IS FROM CENTERLINE OF RESPECTIVE MANHOLES.
- 2.) PERCENT GRADE IS CALCULATED FROM CENTERLINE TO CENTERLINE OF RESPECTIVE MANHOLES.

RIM ELEVATIONS SHOWN ARE APPROXIMATE. FINAL RIM ELEVATIONS WILL BE ADJUSTED TO MEET FIELD CONDITIONS. RIMS SHALL BE LEFT APPROXIMATELY 1" ± ABOVE FINISHED GRADE.
